CALL FOR ABSTRACTS (FREE PAPERS, ORAL PRESENTATIONS, DIGITAL E-POSTERS)
(Open to Orthodontists and Orthodontic Registrars)

- Abstracts must be original.
- They must not be or have been presented or published in whole or in part.
- Deadline for abstract submission is 18th of April 2026. Late submissions will not be accepted.
- All submissions should be made through email to sljo.editorialoffice@gmail.com and CC to amriazeez@yahoo.com as an MS Word document.
- Please note that no amendments to the submitted abstracts will be entertained after the closing date. All presenters are required to register for the conference by the deadline and are required to be physically present.
- Each author is permitted to submit a maximum of five (5) abstracts only.
- A panel of reviewers will review the abstracts anonymously and the decision of the Abstract review committee will be the final.

The abstract may be accepted for oral/ poster presentation or rejected. The corresponding author will be informed of the result.

ORAL PRESENTATIONS

- Each paper will be allowed only 12 minutes for presentation with 3 minutes for discussion.
- Parallel sessions may be conducted depending on the number of papers selected. Multimedia facilities will be made available.

POSTER PRESENTATIONS

- Parallel sessions may be conducted depending on the number of papers selected.
- Multimedia facilities will be made available.
- It is mandatory to indicate your new abstract number in the upper right corner of the poster.
- The usable poster board surface is 150 cm high and 90 cm wide (portrait format). Use 500 to 1'000 words (including title, figure legends and tables)
- The figures and tables should cover approximately 50% of the poster area.

INSTRUCTIONS FOR ABSTRACT SUBMISSION

- Please upload the abstract as an MS word document.
- Language of presentation should be English with correct grammar and spellings
- Font: Times New Roman
- Font size: 12
- Spacing :1.5
- Alignment: Justified
- Abstract title: Should be concise and state 6 keywords relevant to the abstract. Limited to 25 words in UPPER CASE.
- The Author(s) name(s) should be in the format of family name followed by initial(s) without punctuation. A superscript number should be placed after each name to refer to the respective affiliations. Affiliations must be listed below the authors. Please do not use prefixes such as Mr/ Dr /Prof.
- Abstract text: limited to 250 words with the following structural format. Introduction, Objectives, Method, Results, Discussion, Conclusion.
- Only recognized and commonly used abbreviations / acronyms are accepted.

 - Daytime and evening phone numbers
